

Privacy Notice

This privacy notice is established in compliance with the provisions of the Federal Law on the Protection of Personal Data in Possession of Individuals.

Sección C.P. 44630, Guadalajara, Jalisco"**, is responsible for collecting your personal data, the use given to it and its protection. Your personal information will be used to provide the services and products you have requested, to inform you about changes in them and to evaluate the quality of the service we provide.

For the purposes outlined in this privacy notice, we may collect your personal data in a number of ways: when you provide it to us directly; when you visit our website or use our online services; and when we obtain information from other sources that are permitted by law. In no case "**Consultoría Legal y Fiduciaria**" will transfer the personal data of its clients to a third party, without the previous consent of the owners.

Procedure for Enforcing ARCO Rights. –

You have the right to access your personal data held by us and the details of their processing, as well as to rectify them if they are inaccurate or incomplete; to cancel them when you consider that they are not required for any of the purposes set out in this privacy notice, are being used for non-consensual purposes or when the contractual or service relationship has ended, or to oppose their processing for specific purposes.

The mechanisms that have been implemented for the exercise of these rights, which are known as Arco rights, refer to the rectification, cancellation and opposition of the Owner regarding the processing of personal data;

1) The procedure begins with the presentation of the respective application to the Arco rights, at the address of our Privacy Office, which was duly indicated at the beginning of this privacy notice.

2) Your request must contain the following information:

Name of the holder of the personal data. Address or any other means of contact. Documents proving your personality and identity. Clear and precise description of the personal data. Any other document that facilitates the location of the data.

3) The deadline for responding to your request is: 15 working days.
